

## **ABSTRACT SUBMISSION GUIDELINES**

### 1. General Information

EUROMAR 2022 will take place in Utrecht, The Netherlands from 10-14 July 2022. Together with our partners, we will provide a stimulating forum to exchange on the most recent breakthroughs in magnetic resonance and to showcase the latest developments of our industrial sponsors. Our mission is to organize a fully live event but our preparations also include backup options (online or hybrid).

You are invited to submit abstracts for poster and/or oral presentation.

Speakers (plenary/invited/tutorial) are invited to follow the same procedure to submit their presentation proposal.

#### **TIMELINES**

- Abstract Submission for Oral Presentations closes: 23 March 2022 (23:59 CET)
- Abstract Submission for Poster Presentations closes: 1 May 2022 (23:59 CET)
- Notification of Acceptance for Oral Presentations: April 2022
- Notification of Acceptance for Poster Presentations: May 2022

# 2. Abstract Submission Topics

The submitter is required to select the most appropriate topic for the abstract in the online submission form. All entries should fall under one of the 13 topics below:

- 13. Single molecule detection/ NV centers



### 3. Abstract Format

### Author(s)

• The person submitting the abstract should be the presenting author of the work.

#### Abstract Title

• Please keep your title informative and concise, and not longer than 15 words.

#### Abstract Layout

- Abstracts must be submitted in English.
- The total length of the abstract should be max. 300 words.

## 4. Submission Policy

- Abstracts will be published exactly as submitted. We kindly ask you to proofread abstracts
  carefully to avoid errors before they are submitted. No changes will be accepted after
  submission. Any abstract considered unsuitable for reproduction will not be published.
- The abstract submission deadlines are 23 March 2022 for Oral presentations and 1 May 2022 for Poster presentations. EUROMAR does not take responsibility for abstracts that are not fully completed and submitted by these deadline dates. Please ensure that your submission has been completed and you have received the confirmation e-mail.
- Incomplete abstracts having "draft" status will not be processed or submitted for review.
- An author may not revise or resubmit an abstract in order to make changes or corrections after the deadline; adding or removing authors after the submission deadline is not permitted. The abstract may be withdrawn or, if accepted, the error may be indicated during the presentation.

# 5. Review and Acceptance

All submitted abstracts will go through a review process by members of the Scientific Committee of EUROMAR 2022.

Following the review process, the final selection will be made by the International Scientific Program Committee of the meeting to define the format and schedule of each selected abstract.

The notification of acceptance or rejection of your abstract will be sent out one month after the submission deadline.

**IMPORTANT NOTICE:** Should the presenting author be unable to present the abstract, one of the coauthors can present in his/her place. An email from the presenting author indicating the change is requested and must be received by EUROMAR no later than 1 June 2022. No changes will be accepted after this date.



### 6. Posters

After an abstract has been accepted for poster presentation, the author will be asked to log back in to the abstract portal and upload the poster in pdf format. Posters will be accessible via the conference app, in addition to onsite.

# 7. Registration and expenses

All presenting authors of selected abstracts must register for EUROMAR 2022 before 15 June 2022.

The EUROMAR will not cover costs incurred in submitting an oral or poster, or for travel and accommodation costs for presenting authors.

Failure to register for EUROMAR 2022 by the set deadline will lead to the withdrawal of your abstract(s).

### 8. Publication of abstracts

All accepted abstracts will be included in the Abstract Book.
